

#### Index Sector Breakdown



Top Ten Index Holdings

- Chinese retail web sales totaled US\$1.14 trillion2 in 2017 (compared to US\$453.5 billion<sup>3</sup> in the United States), representing an increase of 32.2% from US\$869 billion in 20162.
- China's internet population reached 721 million people, a penetration of only 52.2%1. The U.S. internet population reached 287 million people, a penetration rate of 88.5%1.
- Total Chinese retail sales reached US\$5.8 trillion in 2017<sup>2</sup>
- Online shopping accounted for 19.6% of retail purchases in China in 2017<sup>2</sup>
