As the Taiwan Stock Exchange may be open when units of the ETF are not priced, the securities' values in the ETF may change on days when investors cannot trade the units.
- The price of units traded in different counters may deviate significantly. If there is a suspension of the inter-counter transfer of units between the counters and/or any limitation on the level of services provided by brokers and CCASS participants, unitholders can only trade their units in one counter.
- The Manager may at its discretion pay distributions out of capital, or effectively out of capital, of the ETF. Payment of distributions out of capital or effectively out of capital amounts to a return or withdrawal of part of an investor's original investment or from any capital gains attributable to that original investment. Any such distributions may result in an immediate reduction of the NAV per unit.

### INVESTMENT OBJECTIVE

The iShares Core MSCI Taiwan Index ETF seeks to track the investment results of an index composed of Taiwanese equities.



Estimated Annual Tracking Difference = -0.45%

This is an estimated annual tracking difference.

Tracking Difference is the return difference between an ETF and its underlying index over a certain period of time. Tracking Error measures how consistently an ETF follows its underlying index. It is the volatility (measured by standard deviation) of that return difference. Tracking Error is annualized based on the number of dealing days in the past year when daily tracking difference is calculated.


