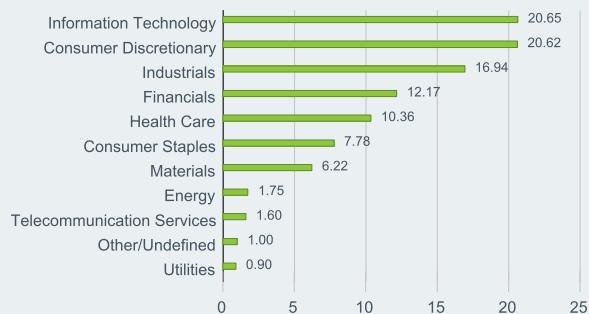

SECTOR BREAKDOWN (%)

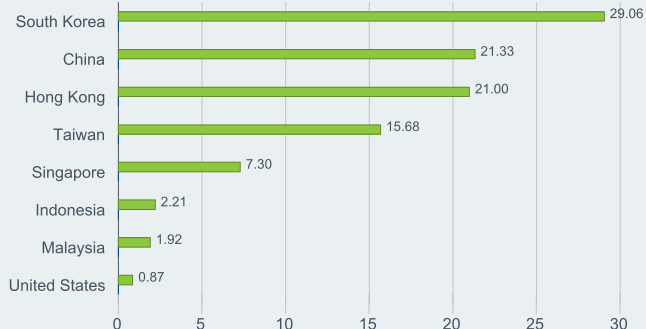
